#### 15-13 RESOLUTIONS OF THE WALDEN FIRE DISTRICT

Whereas, the Fire District has resolved to construct a storage facility;

Whereas, the commissioners of the fire district have determined that the cost of the facility to exceed \$35,000.00;

Whereas, sufficient reserve funds have been saved for this general purpose;

Whereas, the expenditure of reserve fund monies from this general type reserve fund requires that the resolution to be subject to permissive referendum;

NOW THEREFORE, upon motion made, seconded and discussion held, and **subject to permissive referendum**, the fire commissioners of the fire district resolves as follows:

- 1. The Walden Fire District shall be permitted to utilize funds from its Reserve Fund to fund the construction of a storage facility:
- 2. Up to \$500,000.00 may be withdrawn from such Reserve Fund to be applied towards the total cost of the purchase. The withdrawal may be taken in one or more amounts;
- 3. No funds may be withdrawn until the passage of thirty days from the date of publication of the abstract of this resolution;
- 4. The Secretary is hereby directed to send a copy of the abstract to the Town Clerk to be placed upon the town's sign board and the town's website (if one exists) immediately, which must remain there for at least 15 days;
- 5. The Secretary is hereby directed to place an abstract of the resolution upon the fire district's website immediately (if one exists), which must remain there for at least 15 days;
- 6. The Secretary is hereby directed to place such abstract in the newspaper having general circulation in this district.

Chairman Werner made a motion to accept Resolution 15-13 2<sup>nd</sup> by Commissioner Stabner, carried. This resolution was approved by a majority of the commissioners, on the 14<sup>th</sup> day of December, 2015.

# RESOLUTION 15-12 TO AUTHORIZE VOLUNTEER TO ATTEND TRAINING SCHOOL AND INSTRUCTIONAL COURSES OUT OF COUNTY

WHEREAS, General Municipal Law §72-g authorizes volunteer members of the department to attend training schools or courses of instruction for firefighters provided the fire chief authorizes such training, and such authorization is subject to the rules or regulations made by the Board of Fire Commissioners, and

**WHEREAS,** when the training school or the offered course is located outside the county or outside one of the counties in which the fire district is located, the authorization to attend the school or conference must receive prior approval of the Board of Fire Commissioners.

WHEREAS, before this Board of Fire Commissioners is a request by JP Stabner, who is a volunteer with the Walden Fire Department to attend out-of-county training at the NYS Academy of Fire Science for the Firefighter 1 Course located in Schuyler County, NY beginning on June 11, 2016.

**NOW THEREFORE,** the request before the Board of Fire Commissioners of the Walden Fire District by, Brian Stabner who is a volunteer with the Walden Fire Department to attend out-of-county training at the NYS Academy of Fire Science for the Firefighter 1 Course located in Schuyler County, NY beginning on June 11, 2016. is granted subject to the rules and regulations established by this Board of Fire Commissioners.
