RESOLUTION REGARDING TAX FREEZE COMPLIANCE FOR

FISCAL YEAR 2017

Walden Fire District

in the Town of Montgomery

WHEREAS, the Board of Fire Commissioners of the Walden Fire District in the Town of Montgomery, Orange County, New York (the "District") prepared a preliminary budget for fiscal year 2017 with a proposed tax levy in the amount of \$854,762.00;

WHEREAS, upon preparing the on-line tax cap form for fiscal year 2017, the District Treasurer determined the preliminary budget included a tax levy which would require a tax levy increase, for the coming fiscal year, 2017 of more than the permissible tax levy for the fiscal year of 2017;

WHEREAS, WHEREAS, the Fire District desires to comply with Tax Freeze legislation, and did not desire to have a tax levy in fiscal year 2017 above the permissible tax levy;

WHEREAS, the Fire District held a budget hearing on October 18, 2016; and

WHEREAS, the Fire District determined to reduce the budget for fiscal year 2017, to include a tax levy of only \$854,762.00.

NOW, THEREFORE, the Board of Fire Commissioners of the Walden Fire District hereby resolves, by a vote of at least sixty (60) percent of the total voting power of the Board of Fire Commissioners, as follows:

SECTION 1. The Board resolved to comply with the tax freeze legislation for fiscal year 2017.

SECTION 2. The Board did not vote to override the tax cap levy limit for fiscal year 2017.

SECTION 3. The Board voted, on October 18, 2016 at the conclusion of the Budget Hearing, to reduce the budget for fiscal year 2017 to include a tax levy of \$854,762.00, and to comply with the tax freeze legislation.

Upon Motion made by Chairman Werner 2nd by Commissioner Stabner and discussion held, the following resolution was approved by the Commissioners: be it resolved to approve the **RESOLUTION REGARDING TAX FREEZE COMPLIANCE FOR FISCAL YEAR 2017**
